# Construction Industry- Norwegian solutions to lifting heavy slates

Smart solutions to lifting heavy slates is a challenge for professional building crafts companies operating for customers who demand specialist work within restoration and related tasks, not only within cultural heritage, but also for the owners of more modern houses that apply slates for roofing. Tailor-made, easy adaptable chains, in accordance with roof an-

gles reduce the heavy lifting and take the strain away from the backs, arms and shoulders of the craftsmen and consequently contribute to reduced health hazards, improved security and better working

conditions. Mr. Haakon Kvestad also refers to cooperation with other companies during the initial phases and pilot period. Therefore, he was confident that his customers had a very good result once the tool was put to use. It is also important to underline the good results for cultural heritage and preservation. The tool is here to increase productivity, thus avoiding fatal damage to buildings that face collapse.

# Device for the Generation of a Mixture of Steam and Clean Combustion Gas

Professor V.S. Severjani has developed a device for the generation of a mixture of steam and clean combustion gas. The device developed by the Brest University is necessary for the processing of various materials, particularly for ferroconcrete in thermal power plants. The device uses a new type of combustion, which reduces the size and increases the Energy Conversion Coefficient and the product quality. Steam pipes in the chimney of a heating plant are not needed anymore. This device can be useful for companies in the processing industry (for example metal processing or production of construction equipment).

### Solar power plant for small objectives

Professor V.S. Severjani has constructed a solar power plant with helio-concentrate, an energy-collector, and a system which targets the sun. This plant is designed for hot water supply of small objects (houses, industrial buildings, car washes, warehouses, etc.). The design and materials used can reduce the costs of installation and maintenance. The thermal capacity is up to 3 kW.

The Brest State Technical University offers their advice in designing and implementing the above mentioned technical proposals. They will take care of all legal and patent aspects will develop and disseminate promotional material.

# Norwegian Hairdresser- Patent on Hand-Held Hair Dryer

After 30 years of experience within the hair-dresser industry and owner and manager since 1986, Vigdis M. P. Marthinsen has experienced how the traditional hairdryers results in painful strains on elbows, the neck, shoulders and the back. This has inspired Vigdis to develop new solutions where hairdressers do not need to rotate the wrist and arm that much. This work resulted in a function patent.

The Norwegian National Institute of occupational Health (STAMI) has undertaken research in hairdresser industry over the past ten years. The research shows that hairdressing is a profession where disorder in arms, hands and elbow is high, and the many professional hairdressers are forced to seek new professions at an early age. A pilot test by STAMI on the new blow dryer shows that elevated arms are reduced by 40%. This will help the industry to reduce sickness costs and increase average working careers, worldwide. Research from other country shows the same results.

STAMI will undertake research of the testing of Prototype 1 and Prototype 2, and the result will be made public internationally.

# Nottbeck Master's programme: Joint MBA programme from University of Tampere and St. Petersburg State University



The University of Tampere, Tampere University of Tech-

nology and St. Petersburg State University of Economics and Finance are piloting a new Master's Degree programme together with Finnish companies operating in St. Petersburg. The Nottbeck Master's programme was launched 10 February 2011, ant it is part of the

St. Petersburg Business Campus regional cooperation project coordinated by the Baltic Institute of Finland.

Nottbeck Master's programme is an MBA programme on knowledge management for top- and mid-level



managers of companies. It tackles issues of administration and personnel management firmly from the perspective of Finnish and Russian cultures, enhances cultural understanding and focuses on solving the everyday challenges involved in management.

The programme includes lectures at universities, practical work at companies, bench learning and corporate visits both in St. Petersburg and in Tampere. Nottbeck Master's programme is a pilot project which is intended to be continued as a full-scale Russian Trade MBA programme in 2012. The objective of the programme is to strengthen the supply of education and services in Russian trade in Tampere.
